- Attach a copy of your lease and/or a letter of authorization from the property owner granting you permission to utilize the sidewalk in front of the listed property. *Exception: whereas the property owner, per the deed, and the business owner, per the Town records, are the same, this is not required;*
- Site diagram depicting the width of the sidewalk or boulevard along the frontage of the building or property from the building to the curb line and the location and size of the requested extended use area of the sidewalk or boulevard;
- Description of the items to be utilized for the extended use (e.g. planters, displays, patio) including type of material;
- Attach a copy of a Certificate of Insurance naming the Town of Penetanguishene as an additional insured on the policy for not less than Two Million (\$2,000,000.00);
- Completed Indemnification and Hold Harmless Agreement;
- Certificate of Health Inspection, for patios **when applicable**;
- Proof of Liquor license requirements, for patios **when applicable**.

**INDEMNIFICATION AGREEMENT**

**NOW THEREFORE** in consideration of the issuance of the Use of Sidewalk and Boulevards Permit for a beautification item and/or sale of merchandise and/or outdoor patio, or in consideration of permission being granted to the Applicant for the continued display of the said items, the Applicant agrees that it will indemnify the Town of Penetanguishene, and save the Town harmless, from and against any and all liabilities, injuries, property damage, actions, suites, demands and claims that may arise directly or indirectly from the placement and use of the sign in whole or in part on or over any sidewalk or other public property in the Town of Penetanguishene.
