



COMMITTEE OF ADJUSTMENT NOTICE OF HEARING

TAKE NOTICE THAT the Committee of Adjustment of the Town of Penetanguishene will hold an electronic public hearing on MONDAY, JANUARY 27, 2025, AT 7:00 PM to hear a Provisional Consent to Sever application pursuant to Section 53 of the *Planning Act*, R.S.O. 1990. The electronic public hearing will be hosted using the “Microsoft Teams” platform. Written comments are requested no later than January 22, 2025; however, all comments will be received and considered up until the evening of the meeting.

DESCRIPTION OF THE APPLICATION

The land subject to this consent application (File No. B7/2024) relates to the property municipally known as 1736 Caughey Lane (see Location Map attached) submitted by Anthony DeCarli on behalf of John DeCarli. The purpose of the application is to sever three (3) residential lots intended for the future construction of single detached dwellings. The Retained Lot will retain the existing single detached dwelling. The proposed lot configuration is noted in the table below and illustrated on the Location Map.

APPEAL

If a person or public body has the ability to appeal the decision of the Committee of Adjustment of the Town of Penetanguishene in respect of the proposed Consent to the Ontario Land Tribunal but does not make written submissions to the Committee of Adjustment of the Town of Penetanguishene before it gives or refuses to give a provisional consent, the Tribunal may dismiss the appeal.

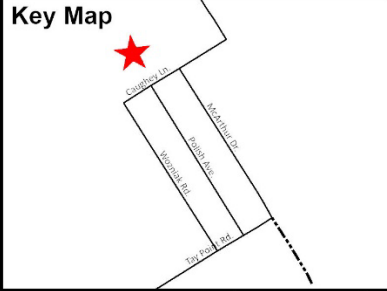

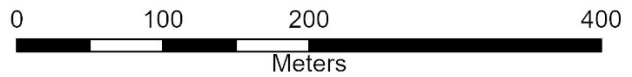


Location Map
