- Mayor Leroux on behalf of the Town of Penetanguishene Council proclaimed August 31, 2021 as International Drug Overdose Awareness Day.
- Council held a Statutory Public Meeting with respect to proposed the Building Permit Fee increase in Penetanguishene. No comments from the public were made.
